On August 13, 2013, the U.S. Court of Appeals for the D.C. Circuit issued a writ of mandamus ordering the Nuclear Regulatory Commission to resume its review of the Yucca Mountain license application. The mandamus order requires the Commission to move forward with the licensing proceeding “unless and until Congress authoritatively says otherwise or there are no appropriated funds remaining.” On August 30, 2013, the Nuclear Regulatory Commission issued an order inviting all participants in the proceeding to provide their views as to how the agency should continue with the licensing process in light of the writ of mandamus.

As the Department of Energy (the Department) has consistently stated, it will comply fully with the law. The Department is committed to complying as expeditiously as possible with any NRC order, subject to the availability of funds. As of August 30, 2013, the Department had approximately \$15.4 million in unobligated carryover funds that could be used to support participation in the licensing proceeding as ordered by the Commission. The Department estimates that it also has a total of \$29.5 million in carryover funds that were previously appropriated in the Nuclear Waste Disposal and Defense Nuclear Waste Disposal accounts, but that are currently obligated on existing contracts. Of these obligated funds, the Department estimates that \$18.1 million is obligated on contracts that are relevant and could be used to support the NRC licensing proceeding. Any of the remaining \$11.4 million in obligated funds would have to be deobligated before they could be used to support the NRC licensing proceeding.

The Department defers to the discretion of the Commission as to the most expeditious and cost-effective manner in which to move forward with the licensing process in light of the writ of mandamus. In doing so, the Department respectfully requests that, in exercising its discretion, the Commission consider the limited funds available to support the proceeding.
